- Racist behaviour, Art. 14 DR
  - Fine: €10,000
  - Partial stadium closure during the next one (1) UEFA club competition match it plays as host club
- Provocative message of an offensive nature, Art. 16(2)(e) DR
  - Fine: €10,000
- Lighting of fireworks Art. 16(2)(c) DR
  - Fine: €14,750
- Improper conduct of the team, Art. 15(4) DR
  - Fine: €3,500
- Field of play, Art. 5 UEFA Stadium Infrastructure Regulations
- Dressing rooms, Art. 11 UEFA Stadium Infrastructure Regulations

  - Partial stadium closure for the next one (1) UEFA club competition match it plays as host club. Said partial stadium closure is suspended for a probationary period of two (2) years.
- Crowd disturbances, Art. 16(2)(h) DR
- Throwing of objects, Art. 16(2)(b) DR
  - Fine: €20,000
  - Ban from selling tickets to away supporters for the next one (1) UEFA club competition match
- Acts of damage, Art. 16(2)(f) DR
  - Contact FC Shkupi 1927 within 30 days for the settlement of the damages caused by its supporters
- Provocative message of an offensive nature, Art. 16(2)(e) DR
  - Fine: €10,000

### **PAOK FC vs. Beitar Jerusalem FC (0:0), 27 July 2023**

#### **PAOK FC**

Incidents and decision:

- Use of laser pointer, Art. 16(2)(d) DR
- Provocative message of an offensive nature (illicit banners), Art. 16(2)(e) DR
- Lighting of fireworks, Art. 16(2)(c) DR
- Throwing of objects, Art. 16(2)(b) DR
- Blocking of public passageways, Art. 38 SSR
  - Fine: €60,000
  - Partial stadium closure for the next one (1) UEFA club competition match. Said partial stadium closure is suspended for a probationary period of two (2) years.

#### **Beitar Jerusalem FC**

Incidents and decision:

- Crowd disturbances, Art. 16(2)(h) DR
- Lighting of fireworks, Art. 16(2)(c) DR
- Throwing of objects, Art. 16(2)(b) DR
  - Fine: €20,000
  - Ban from selling tickets to its away supporters for one (1) UEFA club competition match. Said ban is suspended for a probationary period of two (2) years.
- Improper conduct of the team, Art. 15(4) DR
  - Warning

- Racist behaviour, Art. 14 DR
  - Fine: €20,000

**PFC CSKA-Sofia**

Incidents and decision:

- Discriminatory behaviour, Art. 14 DR
  - Fine: €20,000
  - Partial stadium closure during the next one (1) UEFA club competition match it plays as host club
- Lighting of fireworks, Art. 16(2)(c) DR
  - Fine: €15,250
- Minimum medical requirements, Arts. 11, 12 and Annex B.1 MR
  - Warning

**FC Twente vs. Hammarby Fotboll (1:0), 27 July 2023**

**FC Twente**

Incidents and decision:

- Crowd disturbances, Art. 16(2)(h) DR
- Insufficient limitation of spectator movement Art. 37.01 SSR
  - Fine: €50,000
  - Partial stadium closure during the next one (1) UEFA club competition match it plays as host club
- Blocking of public passageways, Art. 38 SSR
  - Fine: €12,000
