Albania

Incidents and decision:

- Throwing of objects, Art. 16(2)(b) DR
- Lighting of fireworks, Art. 16(2)(c) DR
- Acts of damage, Art. 16(2)(f) DR
 - > Fine: €30,000
 - Partial stadium closure during the next (1) UEFA competition match. Said partial stadium closure is suspended for a probationary period of two (2) years.
- Blocking of public passageways, Art. 38 SSR
 - > Fine: €14,000
- Minimum medical requirements, Art. 11.01 Medical regulations
 - Warning
- Prohibited sponsor advertising on bags, Art. 48.01 Equipment regulations
 - Warning
- Improper conduct of the team, Art. 15(4) DR
 - Warning
- Insufficient organisation, Art. 11(1) DR
 - Warning
- Ticket allocation strategy, Art. 17.01 SSR
 - Warning
- Unauthorised media on the pitch, Annex A.5.3.c. in connection with Annex C of the 2022/28 Commercial regulations governing the European Qualifiers
 - Warning

Poland

Incidents and decision:

- Acts of damage, Art. 16(2)(f) DR
 - > Fine: €5,000
 - Contact the Albanian Football Federation for the settlement of the damages caused by its supporters
- Lighting of fireworks, Art. 16(2)(c) DR
- Throwing of objects, Art. 16(2)(b) DR
 - > Fine: €15,000
 - > Ban from selling tickets to away supporters for its next one (1) UEFA competition matches, for a probationary period of two (2) years.
- Improper conduct of the team (5 players or more), Art. 15(4) DR
 - Warning

Ukraine

Incidents and decision:

- Racist behaviour
 - > Fine: €20,000
 - Partial stadium closure during the next one (1) UEFA competition match
 - > Ban from selling tickets to away supporters for its next one (1) UEFA competition match
- Lighting of fireworks, Art. 16(2)(c) DR
 - ➤ Fine: €5,000
- Blocking of public passageways, Art. 38 SSR
 - > Fine: €8,000

Romania vs. Kosovo (2:0); 12 September 2023

Romania

Incidents and decision

- Blocking of public passageways, Art. 38 SSR
 - > Fine: €12,000
- Lighting of fireworks, Art. 16(2)(c) DR
- Throwing of objects, Art. 16(2)(b) DR
- Provocative messages of a political nature, Art. 16(2)(e) DR
- Racist behaviour, Art. 14(2) DR
 - ➤ Fine: €40,000
 - > Match behind closed doors for its next one (1) UEFA competition match

2025 UEFA European Under-21 Championship

Republic of Ireland vs. Türkiye (3:2); 08 September 2023

Republic of Ireland

Incidents and decision:

- Invasion of the field of play, Art. 16(2)(a) DR
 - > Fine: €2,000
- Insulting players or others present at the match (Mr. Sean Roughan), Art. 15(1)(a)(iv) DR
 - > Suspension: two (2) UEFA representative team competition matches

Türkiye

Incidents and decision

- Improper conduct of the team, Art. 15(4) DR
 - Warning
- Unsporting conduct (Mr. Volkan Aral), Art. 15(1)(a)(v) DR
 - > Suspension: one (1) UEFA representative team competition match
