- Invasion of the field of play by its supporters, Art. 16(2)(a) DR
- Insufficient protection of the playing area against intruders, Art. 40.01 SSR
 - > Fine: €30,000
- Provocative message of an offensive nature, Art. 16(2)(e) DR
 - > Fine: €10,000
- Discriminatory conduct, Art. 14(1) DR
 - > Fine: €30,000
 - > Order the enforcement of the suspended disciplinary measure imposed by the Control, Ethics and Disciplinary Body in its decision of 29 March 2023, i.e. to order the partial stadium closure during the next one (1) UEFA competition match it plays at host club
 - Additional partial stadium closure during the next one (1) UEFA club competition match it plays as host club

Incidents and decision:

- Blocking of public passageways, Art. 38 SSR
 - > Fine: €20,000
- Discriminatory behaviour, Art. 14 DR
 - > Fine: €10,000
 - > Partial stadium closure during the next one (1) UEFA club competition match it plays as host club

NK Maribor vs. Fenerbahçe SK, (0:3), 17 August 2023

NK Maribor

Incidents and decision:

- Throwing of objects, Art. 16(2)(b) DR
- Insufficient limitation of spectator movement, Art. 37.01 SSR
 - > Fine: €40,000

Fenerbahçe SK

Incidents and decision:

- Throwing of objects, Art. 16(2)(b) DR
- Lighting of fireworks, Art. 16(2)(c) DR
- Acts of damage, Art. 16(2)(f) DR
- Crowd disturbances, Art. 16(2)(h) DR
 - ➤ Fine: €30,000
 - > Ban from selling tickets to away supporters for the next one (1) UEFA club competition match
 - > Contact NK Maribor within 30 days for the settlement of the damages caused by its supporters
