 - ➤ To declare the Qualifying Competition matches for the UEFA European Women's Under-19 Championship 2024 Bosnia and Herzegovina vs Liechtenstein scheduled on 24 October 2023, Estonia vs Liechtenstein scheduled on 27 October 2023 and Liechtenstein vs Gibraltar scheduled on 30 October 2023, as forfeited by the Liechtenstein Football Association Women Under-19 national team, who is therefore deemed to have lost the respective matches 3-0
