 - Order the enforcement of the suspended disciplinary measure imposed by the Control, Ethics and Disciplinary Body in its decision on 20 October 2023 i.e. to ban Fenerbahçe SK from selling tickets to its away-supporters for one (1) additional UEFA competition match
 - > Fine: €80,000
 - > Ban from selling tickets to its away-supporters for one (1) additional UEFA competition match

Incident and decision:

- Lighting of fireworks, Art. 16(2)(c) DR
 - > Order the enforcement of the suspended disciplinary measure imposed by the UEFA Control, Ethics & Disciplinary Body in its decision of 13 December 2023 i.e. to order the partial closure of the Servette FC's stadium during the next one (1) UEFA competition match
 - > Fine: €20,000
 - Partial stadium closure during one (1) additional UEFA competition match as host club. Said partial stadium closure is suspended for a probationary period of two (2) years.

 - > Fine: €15,500
